Take Control Initiative (TCI) works to remove barriers and increase access to birth control in Tulsa County.

TCI envisions a community in which all people have equitable access to birth control, ultimately promoting community health and economic opportunity.

TCI DRIVES CHANGE

by breaking down social, economic, and clinical barriers to access for contraception

OPERATING FRAMEWORK

Since 2010, TCI has worked to ensure individuals have the resources and information to decide if and when they want to become pregnant in an effort to honor and support their autonomy and safety. In coalition with a strong network of partners, TCI builds sustainable bridges between community and health centers.

TO CREATE THIS REALITY, TCI PROMOTES THE FOLLOWING CONDITIONS FOR TULSA:

- Everyone has access to all birth control options and is supported in self-advocating for their patient rights.
- Health centers and community-based organizations are supported in implementing practices that affirm dignity, trust and respect.
- Systemic barriers, including financial, transportation, language and logistical barriers to health center access are removed.

PROGRAM ADAPTATIONS

Free Emergency Contraception and Condoms:

By Mail

TCI offers the option for free emergency contraception, condoms, pregnancy tests and more to be discreetly shipped by our pharmacy partner, RevanRx. Each package comes with information about other birth control methods and TCI services.

By Pick Up Sites

TCI partners with multiple clinics, community organizations, businesses, and school institutions to supply them with the "Just In Case" kits, allowing people day of access.





In its 5th year, TCI+ expanded to more clinical partner sites, trained more clinical staff & increased access to emergency contraception in response to federal & state restrictions.

COLLABORATIVE CLINIC TOUCHPOINTS IN 2022

PEER HEALTH EDUCATORS (INCLUDING 8 LEADS) ACROSS 6 POSTSECONDARY SPACES

Take Control continued the peer health education program implementing virtual education sessions, resource dissemination on campus, and recruitment and engagement of students.

PHE members receive training in sexual health and leadership content, and receive stipends for participating. The program both supports student-led TCI education and outreach efforts on campuses and provides the students with a career development experience.







Metriarch® is a statewide data collaborative that aims to normalize and broaden women's health conversations in Oklahoma through data storytelling, resource curation, and interactive outreach events. There are 38 partners across the state of Oklahoma

THE CORE ACTIVITIES METRIARCH® CARRIED OUT IN 2022 INCLUDE:

- The Legislative Tracker platform tracked 57 bills
- Fierce Facts Newsletter
- Tracking and disseminating data on over 40 indicators related to women's health in Oklahoma
- Legislative Clearinghouse Calls every Friday throughout session
- 32 presentations to groups ranging from regional ACOG and national organizations such as AISP with U Penn and BMMAC to the Oklahoma Partners in Rural Public Health Conference
- The launch of Metriarch®'s Judicial Guide which provides unbiased information about state judges. This resource was created in response to the community feedback regarding the lack of information regarding judges running for office during elections.





Our Stories Reflect the Sky

Behind every data point exists a person's story. The narratives in the 2022 report "Our Stories Reflect the Sky" represent the lived experiences and struggles of women across Oklahoma, in our families, and even ourselves. "Our Stories Reflect the Sky" is a qualitative research project from Metriarch® that seeks to ensure community leadership in Oklahoma understands the nuances of women's health within our state.

Metriarch® hosted two in person outreach events in 2022 — one in OKC and one in Tulsa. Both events celebrated the launch of "Our Stories." 40 community partners, stakeholders and lawmakers joined Metriarch® in OKC in April and over 40 joined Metriarch® for the Tulsa event in October.

In 2022, Take Control's social media campaigns reached about **486,386 people in Tulsa and Oklahoma County.** TCI's strategies consisted of running multiple campaigns year around in English and Spanish.

Due to generous funding, a whole new audience was targeted — Oklahoma County. TCI expanded health services and launched emergency contraception (EC) campaigns that promoted free delivery AND pick up sites. With an increase in demand, TCI created an online order form that changed the way ads were promoted.
